To make the underprivileged children self sustained when they grow up.


## Our mission

Saikripa's mission aims to enable the parentless children to earn not just their livelihood but also respect in society.



Survival, health, nutrition, education, development, protection and participation are the undeniable rights of every child. Balkutir is an intervention that is a home to provide and uphold the above to the orphans and abandoned children in our society. Beginning with just one child in 1990, today Balkutir is home to more than 51 children of all ages. More than 300 children have so far been benefited by Balkutir.



"Dream + Do" - This is the motto impressed upon the children of Balkutir, as Saikripa realizes the importance of acting upon the dreams. Because Saikripa believes that dreams are worthless without action. Children are encouraged to offer prayers in the morning and in the evening as it cultivates the habit of introversion that will make them upright morally and develop the power to concentrate.

# Achievements

Since its inception Saikripa has been striving to make children independent.

- Some children have settled in life after completing their studies and getting a job with Saikripa's support.
- 4 girls have been married off after securing appropriate jobs. All these children have been brought up in Balkutir since their childhood.
- 10 children have completed their Secondary board exams and are pursuing their higher studies.

Text books are no longer the singular source for getting knowledge and learning. Despite claims that the arrival of the internet has led to a decline in the reading habits of the children, books and movies continue to be a goldmine of knowledge and information. Hence Balkutir children are encouraged to read books and watch TV in their leisure time.

Our commitment to expertise, care and compassion along with our unflagging vision has helped Balkutir become one of the most trusted homes for underprivileged children that transforms their lives for good

# **Extra-curricular Activities**

**Learning beyond the classroom:** Today, education is no longer restricted to text books and classroom teaching; it is also about engagement and interaction. With this in mind the teachers of the schools of Saikripa take children out to various functions, outings and other activities for participation/involvement, that help students comprehend what they learn. At the same time they pick up other skills such as how to express themselves, to think 'out of the box' and team work.

This year also the children of Balkutir were taken for camp to Shahpur near Bhopal during their summer vacation in May- June 2014. This is a secluded place with natural surroundings such as flora and fauna, hillocks, streams etc. The children camped here taking up different activities such as cooking their own food and participated in activities like swimming, trekking, sports, organic farming etc. The camp life inculcated in them a spirit of adventure and exploration, and provided opportunity for building endurance and self-confidence among the children especially girls.



## **More Activities**

Our Volunteers Visit Balkutir and train the children in various action like dances of different kinds like hip hop, Bharatnatyam, free styles etc. Water colour painting, canvas painting, crafts cooking etc.

The Children of Balkutir perform in the cultural shows conducted by the neighbourhood, RWA and other forums wherever invited.

## SAI SHIKSHA SANSTHAN



India has 1.7 million 'out of school children' in 2010. Investing in education, especially for girls, alleviates extreme poverty and boosts wider development goals through securing substantial benefits for health and productivity as well as democratic participation and women's empowerment. Seeking to empower the underprivileged children through education, Anjina started a school in the rural area of village Wazidpur, Noida in the year 1991.

The reason for Sai Shiksha Sansthan to be located in a rural area is the fact that even today 42% of rural India does not have primary schools. This village, as early as 22 years back, had neither access for any school nor any proper transport for the children to commute to the nearest school which was about 10 to 15 km away. Started with just 80 children as a co educational English medium primary school this has now grown to be a secondary level school with strength of about 400 children.

The heavily subsidized fee of Rs 35/= per month has been progressively increased to Rs. 400/= over the years. The children from the families below poverty line are given free education. It is notable that the same kind of education is given in the schools run by non NGO bodies on a fee of more than about Rs. 1500/- per month.

Saikripa felt the need to shift the focus from "Right of Access to education" to "Right to learn in order to achieve the promise of RTE (Right to Education) and quality education". We have laid emphasis on value education, sports and extra-curricular activities and have taken steps to blend technology appropriately into class room teaching and other spheres of academics and administration.



Our strengths are our committed team of teachers and sincere supporting staff. The teachers are inspired to deliver better coaching through various kinds of workshops conducted for them where there is sharing of knowledge for enhancing their competencies and empowering them to take decisions. This also ensures that the teachers undergo a paradigm shift from the

current educational system which focuses primarily on rote learning from text books.

Schools see a surge in enrolment but interest in science dips. Hence students are encouraged to take interest in science with the facilities of laboratory etc. So far 16 batches of students have completed their 10th STD.

## **ACHIEVEMENTS**

Our children from class V have participated in relay race and other sports activities conducted in Genesis Public School among primary and secondary sections and won silver and bronze medals.

Out of the students appeared for CBSE board exams, two of them secured 86% aggregate marks and others have also scored more than 60% aggregate marks in Higher Secondary Exams.

## **Extra-Curricular Activities**

**Sports:** New age learning places almost equal importance to soft skills such as team work, leadership and discipline, along with education. Sports can be a learning tool that teaches these soft skills. So, Sai Shiksha Sansthan has modified its formal academic approach to incorporate sports and enable children to learn these soft skills.

Activities: Apart from the sports activities in the school, the students participate and win medals and trophies at various inter school sports competitions and activities conducted by Concern India Foundation or other corporate bodies. They also actively participate in various activities such as tailoring, cooking, fine arts like music, dance, painting etc.



**Educational Trips:** Today 'education' would imply any platform that is creating a learning environment for a student. Just as this meaning has evolved, so has the application. One such platform is educational trips that stimulate the mind and give children an opportunity to observe, learn and develop the zeal for exploration.

Awareness Activities: One of our supporters HCL Technologies Foundation sponsored a short film titled 'CHUPI TODO' that was exhibited in their office auditorium at sector 3, Noida for the teachers of different schools run by NGOs and later on in the schools for the benefit of the students. The subject of the film was about sexual abuse. The aim was to create awareness among the children regarding the different kinds of behaviour of the neighbours and even relatives towards them, that may be distasteful and with bad intention. The film tells how to avoid them and bring this to the notice of their parents and well-wishers.

A two day workshop was conducted for the senior students of Sai Shiksha Sansthan on 'Environment' unfolding the knowledge on various aspects like recycling, water harvesting, pollution and guiding them on how the environment is preserved.

# **CASE STUDY**



Name: Parul Sharma Father: Late Mr.Ramveer Sharma Mother: Mrs. Ramvati Sharma Address: Village Wazidpur, Sector 135, Noida.

She belongs to Wazidpur village. She has two elder sisters and two younger brothers and one younger sister Her father passed away when she was just four years old. Her mother worked as a daily wager in her relative's field to bring up these children. Her mother worked hard to educate all the children

She joined in nursery class in our school Sai Shiksha Sansthan and studied up to class X. She was one of our first batch students who gave their X Board Exams through Bloom Public School which is located in Ghaziabad. She scored 65% marks in class X. After that she joined Frobel Public School in Sector 49, Barola, and Noida in Commerce Stream and completed her class XII with 70% marks. After that she joined distant education in Delhi University for B.Com and is doing her III year now. She has participated in group dance, sports and other activities while studying in our school. With much hard work and with great difficulty she has come up to this level. She also participated in sports competitions organized by Concern India Foundation.

At present she is working as a teacher in Sai Shiksha Sansthan teaching preprimary and primary classes. Apart from teaching the subjects she is also taking hobby classes for children in the school.

## **Case Study of Ashu**

Ashu is studying in class III in our school. After the death of his father, we considered him as a beneficiary. He has lost his father 2 years before. His mother is housewife. He has 2 sisters and 2 brothers and all are studying in our school. Before joining our school he was not having any knowledge of school discipline, but after joining our school he started following a disciplined life like getting up early in the morning and doing his homework regularly and he has shown improvement in his studies.

## **SAI BAL SANSAR**



Sai Bal Sansar is a charitable informal school to make such children literate. It has strength of 150 students. Saikripa believes that developing minds and bodies need nourishment. It is relevant to note here that India is a home to a quarter of the world's hungry. Hence the children attending the Sai bal Sansar are provided with free mid-day meal. Besides, this attracts these children to attend the school regularly.

Despite this the drop outs still exist to some extent due to the migrating labour community and hence the strength of the school keeps varying. Being an informal school, all the eligibility norms observed for admission in formal schools are ignored since the intention is to train these children to attain a level of literacy / knowledge that will make them fit and suitable to join the mainstream schools in the appropriate classes leading to 10th std.



A total of twenty students have passed out from Sai Bal Sansar after attending an education level fit enough to study in 6<sup>th</sup> std to 9<sup>th</sup> std and joined main stream schools of private and govt further the following success stories are also to be noted.

## **Other Activities:**

The children of Sai Bal Sansar attended the Christmas Carnival conducted by Pathways School, a high profile School in Sector-100, Noida. The children of Sai Bal Sansar made a sale of various handicrafts made by themselves to the value of Rs. 10,500/-

Apart from this the children are given minor sports activities like lemon, spoon race and long jump inside the limited space available in the school premises.

Once in a week yoga classes are also conducted. Volunteers from AOL (Art of Living), HCL, Pathways School visit the students and give training in life skills and other social aspects in the daily practical life.



#### Success Stories:

**Junaid**, a student joined the school at the age of 12 yrs and studied for five years in Sai Bal Sansar. When he joined the School he was totally illiterate. Within five years he was brought to the level of 8<sup>th</sup> std in his education. He left the school and at his age of 18 yrs he is working in a private company earning more than

Rs. 8000/- p.m and also simultaneously continuing his studies through NIOS for his 10<sup>th</sup> std and reported to be doing well.

# SAI VATSALYA VATIKA

This is an informal special school for children with special needs. Over half the children described by the government as 'children with special needs' (CWSN) are not in schools. This is despite the Delhi high court's ruling for setting aside of seats by schools in nursery class for CWSN.

Saikripa incepted this school in the year 2009 to provide education to children with not only physical disabilities but also learning difficulties such as ASD (Autism Spectrum Disorder) etc. Due to lack of space we have very few children in this school. However, teachers in this school play multiple roles by being friendly and caring and having a child centred approach to learning. This school practices art based pedagogy i.e. learning through integrating various subjects with different modules of art such as painting, drawing, paper cutting, theatre, dance etc.

These activities ensure an all-round personality development of the children and tap their hidden talents, thus contributing in making them smart, self-reliant, articulate, amiable, intelligent, responsible, and global citizens of tomorrow. Students here come from marginalized sections of the society and they avail the free midday meal provided in the school.






# SAI VOCATIONAL TRAINING CENTRE

Skill development is more necessary than the academical qualification for makinga living for the less educated. The children belonging to the weaker section of society are hardly able to pursue their education for higher studies or on professional line. This situation made the

importance for initiating this Vocational Training Centre that gives courses on Tailoring, Computer, Parlour, Bakery and Spoken English



This project is bringing in visible changes and positive impact on the job opportunities and the earning capacity of the successful students from Sai Vocational Training Centre as the emphasis is laid on developing entrepreneurial skills which adds to the overall development. Sai Vocational Training Centre is training people slowly but surely.



#### **Case Study**



Shri Shukveer Kasana aged about 20 years joined the computer course in Sept. 2014. He was living in village Kasna with his parents and a married sister. He has passed 12<sup>th</sup> standard from the Govt. School of Kasna. As his parents were reluctant to take him to higher studies due to various reasons. He migrated to his sister's home at Noida. He tried for some jobs to earn his living but failed in his attempts due to the lack of computer knowledge. And as such he was very keen to do some computer course. His sister sympathetically supported him to take a course in computer centre in Sai Vocational Training Centre for about two months and then she discontinued her financial support. At this point of time Sai Vocational Training Centre gave concession in his fee and completed the balance two months of the course successfully.

This training in Sai Vocational Training Centre enabled him to secure a job in a call centre at sector 2, Noida in the field of data entry and is earning sufficiently.

# **Our supporters**

All our projects are run by the donations from general public, a couple of corporate houses and grants by funding bodies. If Sairkipa could continue its philanthropic services to give a new life to the underprivileged children for more than a quarter century, it is undoubtedly due to the support of each and every donor. It might be too formal to thank them as they are our partners in this noble cause. Their regular contributions significantly makes a positive difference in our resources.

**CONCERN INDIA FOUNDATION** Concern India Foundation has been supporting our School project Sai Shiksha Sansthan for the payment of the salary of the teachers since last nineteen years. The range of their support started from 70% has tapered to 23% of the total salary of the teachers as of now. Without their support Sai Shiksha Sansthan project would not have survived in the initial stages although this project is now being supported in a major way through the donations from general public, corporate houses and funding agencies.

**GIVE FOUNDATION**: This is a funding agency operating both from India and USA. They channelize the donations from different sources to the needy non-profit organizations doing charitable works like Saikripa. We have been getting financial support to different purposes in our projects Balkutir and Sai Shiksha Sansthan for the past thirteen years. Give Foundation was instrumental in getting recognition by Credibility Alliance for Saikripa which critically examines the way funds are spent by the NGOs periodically.

**CHARITIES AID FOUNDATION**: This is also operating both from India and USA but we get most of the support from CAF India since last decade. The funds are utilized for the welfare of the children in Balkutir. It is worth mentioning here that CAF has got a unique scheme called 'GAYE' viz. Give As You Earn. In this, the employees of different corporate Houses make their contributions from their salary which is equalled by the company management thereby the employees have the satisfaction of contributing for a social cause.

This year the project, Sai Vocational Training Centre is being supported in full by **CAF**-**Accenture.** Their support is enabling Saikripa to **get Employment** to the youth from the weaker section of the society besides giving some relief to Saikripa in the management of the funds.

**HCLT FOUNDATION:** They have been giving the grant for the past three years for the nutrition of the children in Balkutir and also a small part of the salary for the staff in Sai Shiksha Sansthan.

**Project and Development (India) Ltd.:** This Public sector unit located in Noida has been regular in supporting Saikripa, specifically Balkutir.

## BHEL HEAVY ELECTRICALS LIMITED

This year M/S BHEL extended their support through their CSR scheme for making and erecting sign board for Balkutir and buying Godrej Cupboards for Sai Shiksha Sansthan.

**Q.A Info Tech.:** Apart from being a donor to Saikripa financially, they have absorbed Pallavi, one of our girls of Balkutir who is doing her B.Com and Company Secretary's courses simultaneously as an accounts assistant in their accounts section.

### Shri Rama Charitable Trust:

This is a trust run at Chennai whose representatives in New Delhi contribute to Saikripa every month grocery items that supplements the requirements for Balkutir, the home for children. Apart from this they regularly contribute a sizeable amount for occasions like wedding performed for the girls in Balkutir periodically.

### **UNWG Queens Group:**

This is an NRI body in the United Nations in New York. For so many years they are giving donation regularly to Saikripa for the welfare of the underprivileged children.

## Support for other suffering NGOs

Saikripa shares groceries, clothes and other items received in donations with the under mentioned NGOs functioning for the welfare of the children as our motive is welfare of the underprivileged children not only in Saikripa but also of other NGOs in need.
